**Essential:**

- Bachelor's degree of a recognized University
  - Audit/ Accounts Officer or Assistant Audit Officer with 5 years service from Audit and Accounts Department are eligible for deputation.
- Period of deputation:** 1 year extendable upto 3 years.

2. **Assistant Director (Research)**- one post **OBC** (Direct Recruitment basis)  
(Level 10 of Pay Matrix i.e. Rs.56100-Rs.177500)

**Essential Educational Qualification:**

- At least second class Master's degree preferably in History, if not II class master's degree in Pol. Sc. Or Economics with 5 years teaching or Research experience or Ph.D. degree in History, Pol. Sc. Or Economics with 3 years teaching or Research experience
- Age Limit:** Max. 35 years.

In respect of applications received only by post (by ordinary/registered/ by speed post/ from the candidates residing in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Jammu & Kashmir, Lahaul and Spiti district and Pangi sub-division of Chamba District of Himachal Pradesh, A&N Islands or Lakshadweep or abroad), the last date for receipt of applications will be 37 days instead of 30 days. The benefit of extended time will be available only in respect of applications received by post from the above mentioned areas/regions. In the case of applications received by hand or through courier service, benefit of extended time will not be available regardless of the place of residence of the applicant.

**General Conditions:** - 1. The post applied for should be clearly indicated in the application and also superscribed on the envelope containing the application. 2. Candidates working in Government organization/PSU should forward their applications through proper channel. 3. Age relaxation would be provided as per the rules. 4. Any attempt to influence the Council in any manner would disqualify the candidate. 5. Mere submission of application & fulfilling the eligibility criterion would give no right to any person for interview/selection. 6. Selection Committee/Chairman, ICHR may relax any eligibility conditions in case of deserving candidates. 7. The selected candidates should be prepared to work at any place in India.

**Note:** Only shortlisted candidates will be called for interview. The ICHR reserves the absolute right to decide as to whether to hold written test or personal interview or both for selection of the candidates for respective posts. The decision of the appointment authority will be final in this regard. Incomplete applications will be rejected.
