ESTABLISHMENT OF THE COUNCIL

The Indian Council of Historical Research was established by the Government of India as an autonomous body registered under the Societies Registration Act with a view to giving a proper direction to historical research and encouraging and fostering objective and scientific writing of history.

The Council came into being on 27 March 1972 when it was inaugurated by Dr Gopal Swarup Pathak, Vice-President of India.

Message from the President of India

The President of India welcomed the establishment of the Council and in a message said: "Historical research is of fundamental importance to a nation like India which is rich in history. A proper historical perspective is necessary to understand the real significance of the great many political, social and economic changes that are taking place in the present-day world".

Message from the Prime Minister of India

In a message sent on the occasion of the inauguration, the Prime Minister said: "The establishment of the Indian Council of Historical Research is welcome. I hope this will encourage objective and scientific research in various aspects of our history. People must be made aware of the influences which have moulded them over thousands of years so as to be able to face the problems of change without losing their moorings.

"It is up to historians to give vision to a people. Vision can be sustained only if the study of history is freed from the shackles of an artificially created framework. The history of India is far too identified with political or cultural conflicts. There seems little concern with the people themselves, with the forces of change in society, and the process of culture. Sometimes mere chauvinism and blind acceptance of the past passes off as a re-interpretation of history.

"Our approach to history must be rigorously scientific. Historical analysis should take account of the whole complex of interaction between the economic, political, intellectual and technological factors.

"I hope that the work of our historians will add to our knowledge and to our understanding of ourselves."

Extracts from Addresses at the Council's Inauguration

DR G.S. PATHAK, VICE-PRESIDENT OF INDIA

"It is of the utmost importance that attempts should be made to close the widening gap between the research done in Indian history and the textbooks taught in schools and colleges. At present it seems that the history textbooks used in our educational institutions are at least twenty-five years behind the knowledge obtained through published research. In the cases in which worthwhile theses are not yet published, this knowledge remains confined only to the researcher and his three or four examiners. Efforts, therefore, will have to be made to get the really good theses published and to make the important conclusions of these works available to the people.

"An important step in this direction would be to make full use of the results of archaeological excavations of the last twenty-five years. They have to be woven skilfully into the main fabric of Indian history together with the literary strands. Our efforts should be directed to the publication of archaeological reports which are long overdue. But even without the results which have not been published much of what is already printed remains to be brought into the mainstream of Indian. history. No book gives us the archaeological counterpart of the Rig-Vedic or later Vedic age. Whatever we know about the age of the Buddha still follows the pattern set by Rhys Davida seventy years ago. The archaeological information that we get about the use of iron, punch-marked coins, North black \polished ware and the rise of towns in North India has, not been integrated with what we learn about the period from the early Pali texts. This example can be extended to later periods. Unfortunately, historical archaeology has been neglected, and we badly need information about the material culture of the early and late medieval periods. Of course, industrial archaeology has still to appear in India. But meanwhile, Lsuggest the setting up of a historical museum which can clearly mark the stages of India's progress from the earliest past down to modern times."

PROFESSOR S. NURUL HASAN, MINISTER OF EDUCATION AND SOCIAL WELFARE

"... it is necessary to foster the study of history in India in an integrated manner. As you all know, the scope of history is very wide. It embraces the history of the natural sciences, social sciences and humanities. It includes not only various periods and themes of Indian history, but also the histories of the other parts of the world in their varied aspects. It was therefore felt that the Government should set up an organisation which could discharge this objective by stimulating historical research and promoting the objective writing of history.

"It is hoped that the establishment of the Indian Council of Historical Research will go a long way towards fostering quality teaching and research in history in our country. The objective of the Council is not to duplicate the work done by university departments of history and similar other institutions but to tone up the quality of the research undertaken by them by providing them necessary facilities. The Council will try to strengthen, encourage and improve the historical work that is being done in the country. By itself it will undertake only such work as cannot be done singlehanded by the existing bodies."

PROFESSOR R.S. SHARMA, CHAIRMAN, ICHR

"The historical approach has deeply coloured the study of literature and philosophy in our universities. If we have a look at the earliest doctoral theses and other publications in the field of Indian literature, we will notice that they mostly trace the origin and development of some language and literature. The same is true of philosophy. Our topmost philosophers, such as S.N. Dasgupta and S. Radhakrishnan, devoted themselves to the history and exposition of Indian philosophy, and even now the historical approach to Indian philosophy is being cultivated assiduously. It will, therefore, appear that the study and research in history is important not only for the development of history but also for strengthening social sciences and humanities.

"... It is essential that we should be aware of the various theories of history which affect our thinking. Some emphasize that heroes make history, others say that ideas make history, still others say that social or religious forces make history and yet others stress the role of economic forces in shaping history. It is necessary that awareness of the different types of historical theories be created among the scholars and they be given sufficient support and latitude to choose their own theory and hypothesis..."

PROGRAMMES AND ACTIVITIES

One of the first tasks before the Council was to identify and determine the broad framework of its programmes. With the help of several groups of historians, the Council has formulated the following major programmes which are now in the process of implementation:

- Financial assistance to research projects in history
- Financial assistance for the publication of Ph.D. theses, research monographs and other historical works
- Fellowships for research scholars in history
- Assistance to professional organisations of historians
- Survey of historical research
- Preparation of source materials on Indian History
- Preparation and translation of important books of history for the use of students, teachers and scholars
- Establishment of a Documentation and Library Centre
- Clearing-house functions
- Seminars, conferences and other programmes

In addition, the Council has taken up several special projects.

Grant-in-Aid to Research Projects*

The scheme of financial assistance to research projects formulated by the Council is intended to encourage research scholars to undertake studies in significant areas. The assistance normally covers the pay and allowances of the project staff other than the Director, and related expenditure on travel, books and contingencies.

Financial Assistance for Publication of Theses and other Historical Documents*

Under this scheme financial assistance is provided for the publication of various types of historical studies such as doctoral theses, research projects financed by the ICHR, research studies, monographs, critically edited or translated source material, journals, and biographical and documentation works.

Fellowships to Research Scholars*

Another scheme formulated by the Council to promote research makes provision for award of fellowships to scholars in universities, colleges and other institutions. The fellowship is normally available to those who are already based in an academic institution on a regular basis and who wish to undertake post-doctoral work. However, fellowships are also given to those who take up doctoral work or are likely to complete their doctoral work in the near future.

The fellowships are available for two categories of historians: those doing research in India and those Indian historians whose research work may require study and collection of material outside India. The research fellowship is awarded ordinarily for two years, but may be extended in exceptionable cases for a third year.

Assistance to Professional Organisations of Historians*

The Council also extends assistance to professional organisations of historians, functioning at the national and regional levels, for holding seminars, workshops, symposia and conferences on subjects of historical significance.

Survey of Historical Research

Soon after its establishment, the Council decided to undertake a quick survey of the work done so far in history, particularly during the last twenty-five years, to find out how far this work has added to our knowledge, in what direction historical knowledge has been changing in style, content, context, and perspective, and to identify emerging trends. Based on this survey, the Council hopes to locate the lacunae in historical study which need attention, and plan suitable research programmes.

The Council attaches great importance to preparing and making available source material on Indian History in order to give a strong source orientation to the teaching of history in universities and colleges and for meeting the initial requirements of research students for designing their research programmes.

The Council has, therefore, drawn up a comprehensive programme of compiling, editing and annotating source material on crucial aspects of Indian history. The work is being assigned to various historians in the country. Sources in English, in other European languages, and in Indian languages will be covered under this programme.

Translation of Important History Books

What postgraduate students and research workers of history most need today is access to adequate and objective studies which incorporate up to date historical content and method. To meet this need, the Council has initiated a programme of translating into regional languages selected titles in Indian history written in the last twenty-five years.

Six-Volume History of India

The Council has planned the preparation of a six-volume series on the History and Culture of India reflecting the latest trends and research on the subject. These volumes, two on each period, are intended to provide an objective analysis of Indian History. An Editorial Board has been set up to plan the project.

Documentation-cum-Library Centre

This is an important programme of long-term significance finalized by the Council. The main task of the Centre will be to index and abstract all published and unpublished historical studies done in India, in English and in regional languages, since 1967. The Centre will start functioning from the year 1973-74. Advance action has been initiated during the current year.

Role of Central and State Legislatures in the Freedom Struggle

In the context of the 25th anniversary of India's Independence, the Council has undertaken a project of writing the history of the Role of Central and State Legislatures in the Freedom Struggle. An Editorial Board under the Chairmanship of Professor S. Gopal has been guiding the project.

The first book in the series on the "Role of the Central Legislature in the Freedom Struggle" was written by Dr Manoranjan Jha, Reader, Banaras Hindu University, and was released by the President of India on 15 August 1972.

The second part of the project on the role of State Legislatures consists of a series of eleven volumes covering the provinces of Assam, Bengal, Bihar, Bombay, Central Provinces and Berar, Madras, North-West Frontier Province, Orissa, Punjab, Sind, and Uttar Pradesh. The headquarters' unit in the Council under Dr Manoranjan Jha coordinates and supervises the project. Each State Project is assigned to a senior historian assisted by a research assistant as under:

Revolutionary Activities outside India for India's Freedom

In connection with the 25th anniversary of India's Independence, the Council has planned a 2-volume project on the compilation of sources relating to the revolutionary activities outside India for the country's independence during the period 1905-1947. The first volume covering the period 1905-1927 will be prepared by Professor A.C. Bose, Head of the Department of History, Jammu University, assisted by Dr A.P. Sharma, Lesturer in History, Ranchi University.

History of the Second World War

India, is a member of the International Committee for the History of the Second World War set up in April-May 1967 to promote historical research in the various facets of the Second World War. The ICHR has been assigned the responsibility for setting up the National Advisory Committee on the History of the Second World War and for the general organisation and implementation of the programme. The following areas have been recommended by the National Advisory Committee for study:

- Impact of the Second World War on India's economy
- Impact of the Second World War on Indian society
- Impact of the Second World War on India's relations with the outside world

In connection with this project, Professor Henri Michel, President of the International Committee on the Second World War and Editor of the Journal Revue d'histoire de la 2° guerre mondiale, will be visiting India in early 1973 under the Indo-French Cultural Exchange Agreement. The Council is drawing up his programme. During his three-week stay in India, Professor Michel will visit important university centres and meet historians, interested in the History of the Second World War.

"Towards Freedom"

This project envisages the publication of records relating to the project "Towards Freedom" in a series of ten volumes. The ICHR will select, compile, and edit the material, while the National Archives of India will be responsible for collecting it. The Council has constituted an Editorial Board for this purpose under the chairmanship of Professor R.S. Sharma.

Source Books in Indian and Asian Civilizations

The Indian Institute of Advanced Study, Simla has been carrying out certain inter-disciplinary studies relating to Indian and Asian Civilizations. The Council has now taken up the preparation of source books on these civilizations.

The programme is planned in two parts: one, the preparation of a source book on Indian Civilization and the other, a series of publications on Asian Civilizations. The first part will consist of a one-volume source book of about 600 pages. In regard to the second part, the Council proposes to take up, in the first instance, the preparation of source books on South-East Asian civilizations. A seminar is being planned for early 1973 to which Indian historians and historians of the region specializing in the history and civilization of the area will be invited. It is expected that the seminar will help in giving concrete shape to the project.

Studies in Central Asian Civilization

The UNESCO has initiated a project concerning the study of civilizations of the peoples of Central Asia. The project seeks to promote a better understanding and appreciation of the civilizations of the peoples of Central Asia through studies of their archaeology, history, science and literature.

The part of the project relating to the History of Ideas and Philosophy in Central Asia has been assigned to India. The Council is working out the plan of the project.

Seven other studies relating to the project are in various stages of implementation. The Council held a review of the progress of these studies at a meeting of the Directors of the projects and planned steps for accelerating the pace of implementation. The projects have been assigned as under:

Indo-Soviet Symposium

Under the Cultural and Scientific Exchange programme between India and the USSR, the ICHR has been corresponding with the Soviet National Committee of Historians and the Institute of Oriental Studies, the USSR Academy of Sciences, for organising and participating in Indo-Soviet Symposia. The theme of the first symposium will be "Economic and Social Changes in India and Russia from the 17th to the first half of the 19th Century". The symposium is expected to be held at Moscow in early 1973. The Council proposes to send a delegation of seven historians led by the Chairman of the Council.

Preparatory Committee of the International Committee for Historical Sciences

The Council sponsored the visit of Professor Satish Chandra, Secretary, Indian History Congress, and Member of the Indian Council of Historical Research, to Hareeg Lovi in Yugoslavia where the Preparatory Committee of the International Committee for Historical Sciences met on 21-22 July 1972. The various themes for the session of the International Committee to be held at San Francisco in 1975 were finalised at the meeting.

Exchange of Literature

As a modest first step in establishing contacts with historical societies abroad, the ICHR arranged to send a set of books written in India to the Historical and Literary Society of Afghanistan. As a reciprocal gesture, the Society has sent us the back issues of its publication *Ariana*.

Invitation to Dacca University Professor

Professor A.B.M. Habibullah, Professor and Head of the Department of History, Dacca University, Bangladesh, is to attend the Indian History Congress session that is being held later this month at Muzaffarpur. The Council has invited him to spend a month in India and visit various History Departments in Universities and consult historical sources of interest.

Seminar of Historians

A seminar of historians on the theme "Recent Trends in the Study of Indian History" is to be held in Mysore in February-March 1973 under the direction of Professor B. Sheikh Ali of the Mysore University.

Links with the Indian History Congress

It is visualised that in the near future the Council will be able to establish close academic and organisational links with the Indian History Congress as well as with various history congresses. It is hoped that in due course these contacts will encourage and stimulate the various regional congresses to make a bigger contribution in the search for sources.

Clearing-House Functions

In addition to other functions, the Council will also serve as an information and clearing-house centre in matters relating to historical research. As a first step in this direction, the following programmes have been taken up:

- Directory of Ph.D. Degrees in History awarded from the year 1947 onwards
- Directory of students who have been registered for Ph.D. in Departments of History in various universities
- Synopses of Ph.D. Theses in History
- Directory of Indian Historians
- Directory of Professional Organisations in History
 The last two are being planned.

DECCAN COLLEGE, POONA

The Department of History carried out large-scale excavations at Somnath to understand the development of cultures after the Harappan civilization. During the excavation a very large building (60'x20'), with several rooms was discovered at a depth of 15'. All these rooms are very well lined, though built of stone, From the way the construction had been done it seems that the Harappan tradition in this respect was continued, although the pottery and other remains of the culture had disappeared. Among the most important finds was an obsidian flake and a seal depicting five gazelles. These have been found for the first time in India.

The department also carried out a survey of the rivers Saraswati and Hiran. There is evidence of the existence of Early Man and his successors right at the mouth of the river. There is also evidence to show that the whole of Saurashtra had not gone under the sea during the Pleistocene times; the sea had encroached upon only a mile or two along the coast.

The second excavation was carried out near Betamcherla in the Kurnool district by Dr M. L. K. Murty. This has also supplied very important evidence of the existence of man in upper Pleistocene times in the Kurnool District, the most important of which is the making of bone tools exactly as they were made in Western Europe at that time.

DEPARTMENT OF ARCHAEOLOGY AND ANCIENT INDIAN HISTORY M. S. University of Baroda

Champaner Project

This project includes the study of town planning of a late medieval city of Gujarat by modern archaeological methods of plain table survey, photography, statistical methods, etc. Three seasons' work at the site has revealed a fortified city with a royal citadel within it. This also shows the pattern of nine roads leading to the royal citadel. The habitation contains plans of palatial buildings, hammams, zenana quarters, well, sanitation system, etc. In addition, serais, administrative buildings and gardens have also been revealed.

Last year's study shows Hindu structures on the hill side. Various phases of fortifications have also been exposed.

Gujarat District Project

Exploration of various districts of Gujarat is under way. Several sites of early and late stone-age sites in Banaskantha, Kaira and Panchmaha districts in addition to the one chalcolithic site of Harappan culture have been discovered in Banaskantha. Several sites of the same culture have been discovered in Cambay taluka of Kaira district also.
